- The restricted stock units vest beginning one year from date of grant in three annual installments of 33%, 33% and 34%.
- The restricted stock units vest on 2/03/2014. Vested shares will be paid to the reporting person six months following retirement or termination of service.
- Each share of Restricted Stock Unit is the equivalent of one share of Sonoco Products Company common stock. The shares were cashed out to account for withholding taxes.
- SAR units vest beginning one year from date of grant in three annual installments of 33%, 33% and 34%.
